Membership dues are not deductible as a charitable contribution for income tax purpose, but may be deductible as a business expense. The 1993 Tax Act requires associations to provide members with a reasonable estimate of the non-deductible portion of their dues allocated to lobbying, activities, or to pay a proxy tax on the estimated cost of lobbying. You may contact your association later this year to verify that portion of dues for which are allocated to lobbying and are not deductible. The amount is not anticipated to exceed 10%.
